2022 NW District 4-H Horse Show Governing Guide

- 1. The NW Kansas District 4-H Horse Show will be governed by the Kansas 4-H Horse Show Rule Book, May 2020 version located at https://www.bookstore.ksre.ksu.edu/pubs/ S133.pdf and the NW District 4-H Horse Show Governing Guide.
- 2. **Entry**: Entry in the NW District 4-H Horse Show is a two-part process at showringmaster.com
 - 1) Entry Form and proper fees paid online. You will receive a confirmation Email when fees are paid on line.

Entries will close June 17th, 2022. Entries after deadline will not be accepted. Program will be completed as you entered information online. No addition of classes or changes will be made the day of the show, unless to change to a current ID'd horse by May 1.

- 2) Stall reservation and fees are to be mailed to the address on the stall reservation form. Print the stall form from showinringmaster.com.
- 3. **Fees:** Fees of \$7 per class will be paid online at time of registration. Stall fees need to be mailed with email conformation prior to deadline date.
- 4. Refunds & Level Certification: An exhibitor awaiting notification of level certification (level cert. deadline June 17, 2022) may enter the District Show and will be refunded if level certification is not met. Otherwise, there will be NO REFUNDS. Participants only need Level 1 certification for 9-13 and 14-18 age groups.
- 5. Exhibitors may show in only one Equitation Class, one English Pleasure class, one Horsemanship class, and one Western Pleasure class according to exhibitors age. Age groups are 14-18 and 9-13.
- 6. **Proper identification**: A properly completed 4-H Horse Identification Certificate for current year <u>must</u> be presented to the District Show entry clerks upon arrival for examination and to receive show identification numbers. A 4-H member can only show the same horse at the Kansas State Fair that was qualified at the District Show. There will be no exceptions. A 4-H horse may be substituted between entry time and District 4-H Show, if the horse was properly identified by May 1. A 4-H member must manage & care for the 4-H horse at least 75% of the time between May 1 and September 30. **No animal or 4-H member may show in a class twice.**
- 7. A signed and dated Statement of Humane Treatment and Parent Code of Conduct must be turned into the District show entry clerks at check in the day of the show.
- 8. Classes for state show <u>not requiring district qualification are</u> Three Year Old Project Futurity, level II, III & IV horsemanship, and stall decorating. **Horse must still be nominated by May 1.**

- **9. WARNING:** Under Kansas Law, there is no liability for an injury to or death of a participant in domestic animal activities resulting from the inherent risks of domestic animal activities, pursuant to Sections 1 through 4 of KSA 60-208. You are assuming the risk of participating in this domestic animal activity.
- 10. Accident Policy: Maximum medical insurance coverage for horse-related events is limited to \$500.
- 11. **Horse Health: A negative Coggins test is required** & will be checked at the Scheduled ID times.

12. ID will be from:

Early arrival -- 6 p.m. to 7 p.m. (Evening before show day) Day of show -- 7:30 a.m. to 8:30 a.m. Late arrival -- 11 a.m. to noon (Speed Event horses only)

13. Date of Show-- July 7, 2022 Show begins at 9 a.m. sharp.

15 min. break between Showmanship & English Arena will be open during Trail classes 15 min. break prior to Speed Events

14. ALL DECISIONS OF THE JUDGE ARE FINAL!

15. A Grievance Committee has been established. All grievances will be submitted in writing along with payment of \$250 to the show secretary for ruling. If ruling is changed \$250 will be refunded. If ruling stands the funds will be deposited into the NW District Horse Show account.

(ALL DECISIONS OF THE JUDGE ARE FINAL!)

- 16. During the District Horse Show, only 4-H exhibitors will be allowed to ride horses entered in classes. non-compliance will result in disqualification of ALL exhibitor entries.
- 17. Horses not entered in the show will NOT be allowed on the grounds.


